NOTE: IT IS THE HOME OWNERS' RESPONSIBILITY TO ESTABLISH THE LOCATION OF THE PROPERTY LINES AND THE PROPER LOCATION OF THE FENCE.

Is hereby granted permission to perform the following work to construct or replace a fence and will abide by all provisions of the Borough of Keyport fence ordinance and the following conditions:

1. ALL FENCES SHALL BE INSTALLED WITH GOOD FINISH SIDE TOWARDS NEIGHBOR.
2. NO FENCE SHALL BE INSTALLED CLOSER THAN 6" INCHES FORM YOUR PROPERTY LINE.
3. NO FENCE HIGHER THAN 3' FEET CLOSED OR 4' OPEN STYLE, SHALL BE INSTALLED IN THE FRONT YARD.
4. ALL FENCES SHALL BE INSTALLED FOR PROTECTION OF A POOL, SHALL BE A MINIMUM OF A 4' FOOT SOLID TYPE FENCE WITH SELF-CLOSING GATES AND SELF-LOCKING LATCHES.
5. ALL PERMITS MUST BE FILED ALONG WITH A COPY OF THE PROPERTY SURVEY.
