This letter is to provide you with legal notification that an Individual CAFRA Permit application will be submitted to the New Jersey Department of Environmental Protection, Division of Land Resource Protection for the redevelopment shown on the enclosed plan. A brief description of the proposed redevelopment follows: Deputy Ventures, LLC is proposing to redevelop an existing parking lot on Block 22, Lots 26, 30, and 31 (herein referred to as the "project site") with nine (9) single family homes. The application has been assigned NJDEP File No. 1322-02-0003.3 CAF 160001. The project also includes a public walkway that will extend from Beers Street to West Front Street.

The complete permit application package can be reviewed at the municipal clerk's office in the municipality in which the site subject to the application is located or by appointment at the Department's Trenton Office. Either a 30-day public comment period or public hearing will be held on the application in the future. Individuals may request a public hearing on the application within 15 calendar days of the date of receiving this letter.
