ORDINANCE OF THE BOROUGH OF KEYPORT, COUNTY OF MONMOUTH, NEW JERSEY, AMENDING CHAPTER 7 "TRAFFIC" AND CHAPTER 7A "TRAFFIC SCHEDULES" OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEYPORT

WHEREAS, the Borough of Keyport (the "Borough") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, pursuant *N.J.S.A.* 39:4-197, the Mayor and Council of the Borough of Keyport (the "Borough Council") have the power to adopt ordinances concerning traffic and parking within the Borough; and

WHEREAS, the Mayor and Borough Council hereby desire to amend Chapter 7, "Traffic," Section 14.2, and Chapter 7A, "Traffic Schedules," Schedule I, to reflect revised traffic regulations.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Keyport, County of Monmouth, New Jersey that:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Chapter 7, Section 14.2 entitled "Mid-block crossings schedule" is hereby amended as follows (additions are <u>underlined</u>):

§ 7-14.2 Mid-block crossings schedule.

The following mid-block crossings are located within the Borough:

Broad Street (County Route 4)	From a point 325 feet south of the southerly curbline of West Front Street and to a point 10 feet south thereof	
Broad Street - Central School (County Route 4)	From a point 400 feet north of the northerly curbline of Jackson Street to a point 10 feet north thereof	
Main Street	From a point 40 feet north of the northerly curbline of Hurley Street to a point 10 feet north thereof	
Maple Place (County Route 516)	From a point 5 feet north of the northerly curbline of Orchard Street to a point 10 feet north thereof	

Section 3. Chapter 7A, "Traffic Schedules," Schedule I entitled "NO PARKING" is hereby amended as follows (additions are <u>underlined</u>):

SCHEDULE I NO PARKING.

In accordance with the provisions of Subsection 7-3.3, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Broad Street (County Road 4)	East	From the southerly curbline of East Front

Section 4. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed.

Section 5. Each section, subsection, sentence, clause and phrase of this ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this ordinance.

Section 6. Except as amended by this ordinance, all other provision of the Borough's Revised General Ordinances shall remain in full force and effect.

Section 7. The Borough Clerk is hereby directed, upon adoption of the ordinance after public hearing thereon, to publish notice of the passage thereof.

Section 8. This ordinance shall be in full force and effect from and after its adoption and any publication according to law.
