

**ORDINANCE NO. 2022-23**

**AN ORDINANCE OF THE BOROUGH OF KEYPORT, COUNTY OF  
MONMOUTH, NEW JERSEY ESTABLISHING SALARIES AND WAGES  
FOR DESIGNATED OFFICIALS AND EMPLOYEES**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Keyport, in the County of Monmouth, New Jersey, as follows:

**SECTION 1.** Annual salaries are hereby established for the following elected officials:

**SECTION 6.** The provisions of this Ordinance shall be severable. If any section or provision shall be held invalid by any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, which shall remain in full force and effect.

**SECTION 7.** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**SECTION 8.** This Ordinance shall take effect after final passage and publication in accordance with the law.
